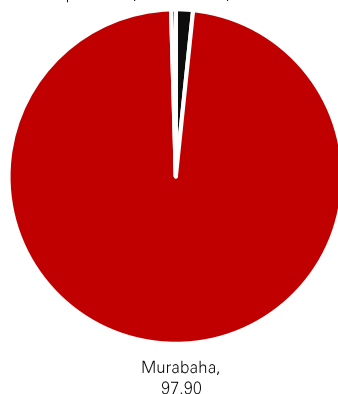

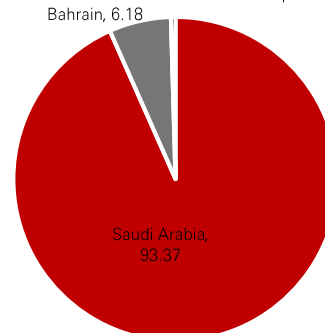
Asset Allocation (%) ⁽⁴⁾

Cash & Cash Equivalents, 0.45 Sukuk, 1.65



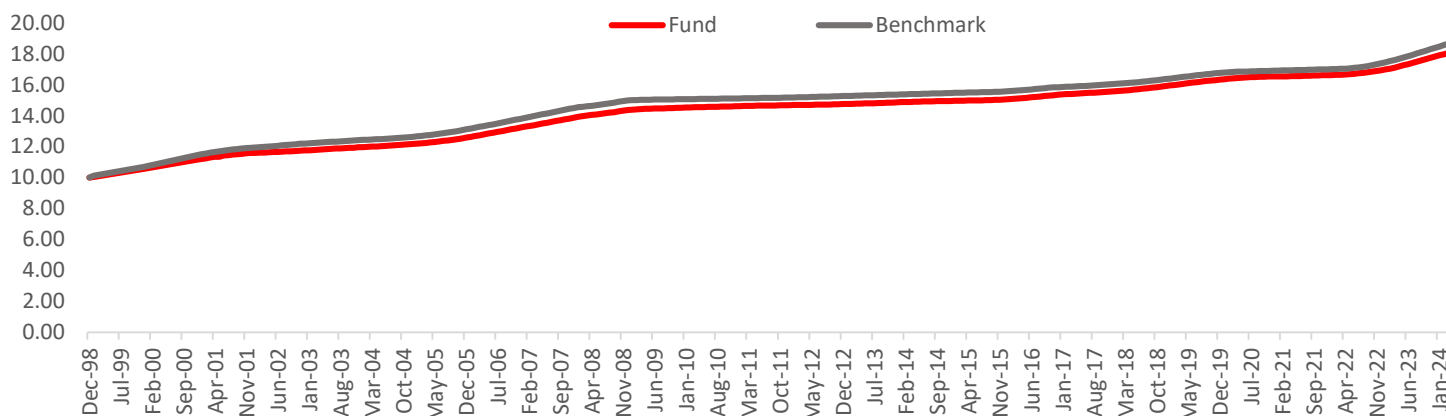
Geographical Allocation (%) ⁽⁴⁾
