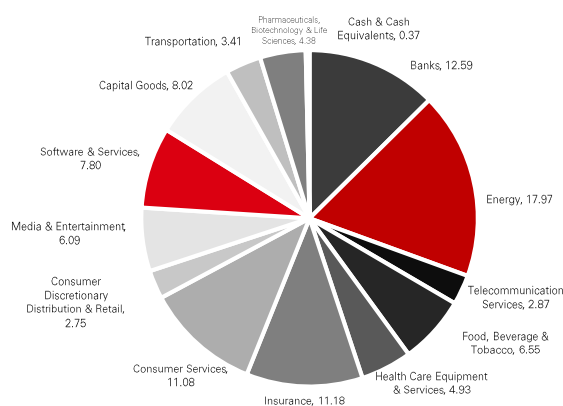

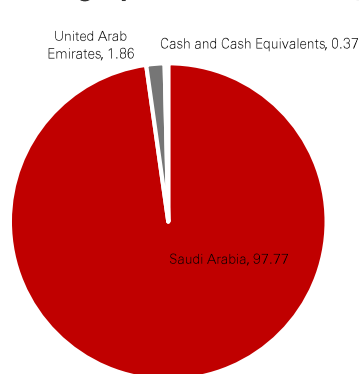

Sector Allocation (%) <sup>(4)</sup>

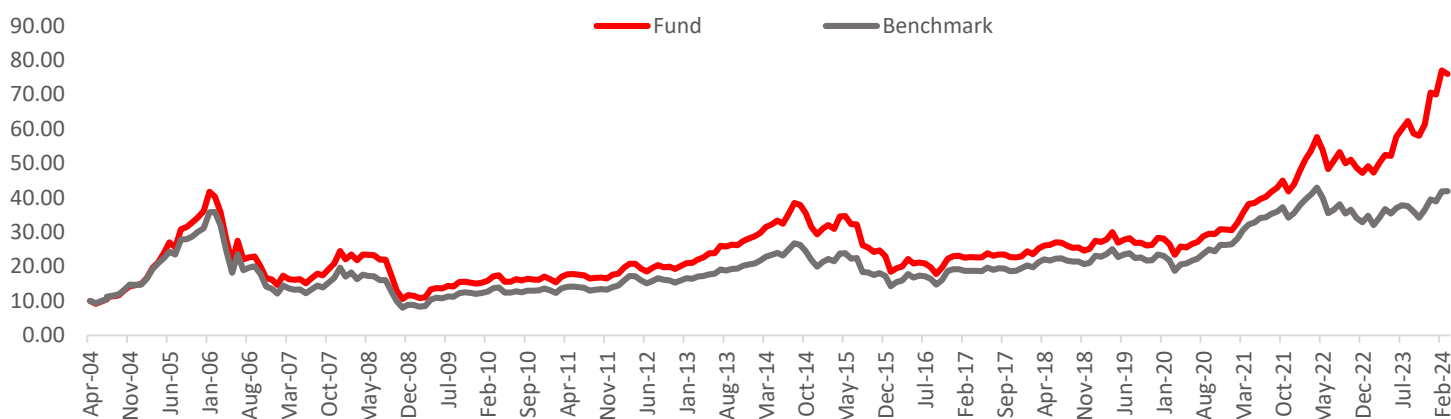


Geographical Allocation (%) <sup>(4)</sup>
