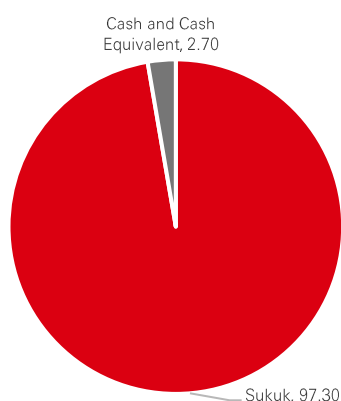

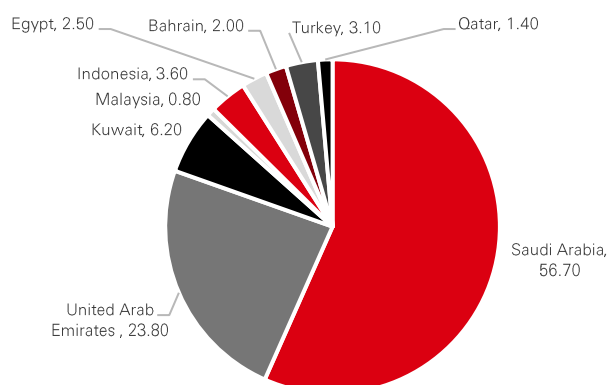

Asset Allocation (%)⁽⁴⁾

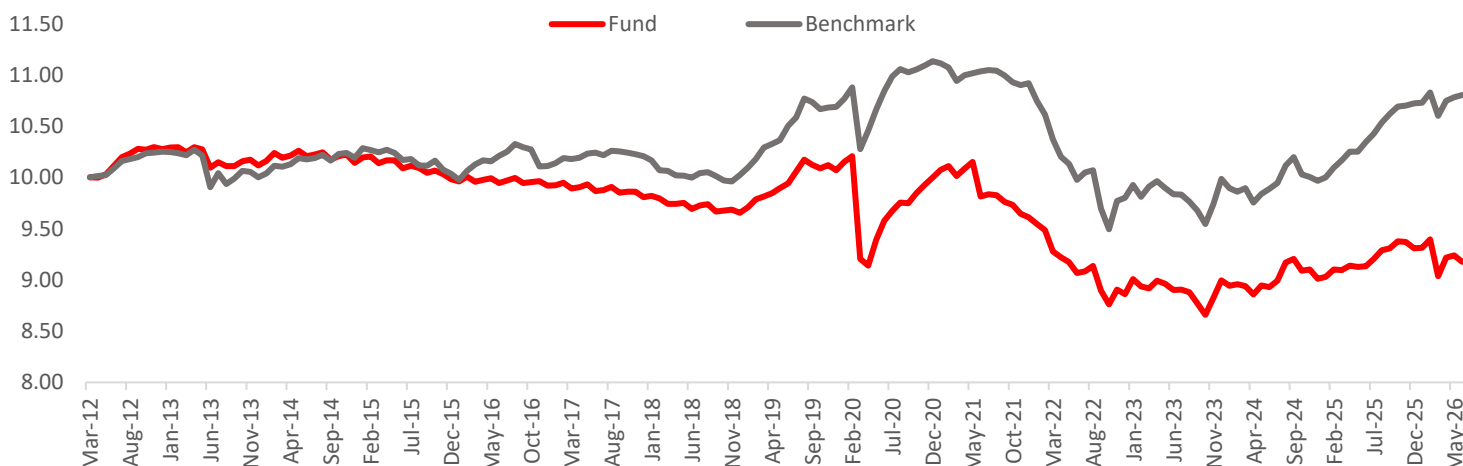


Geographical Allocation (%)⁽⁴⁾
