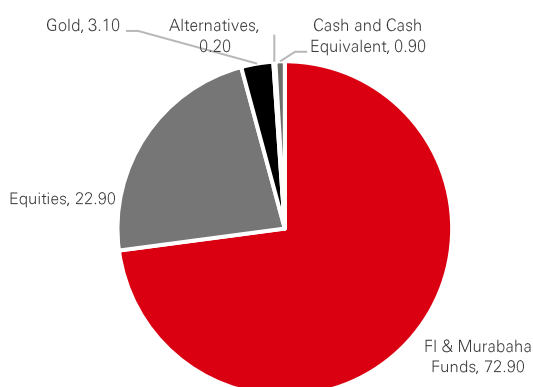

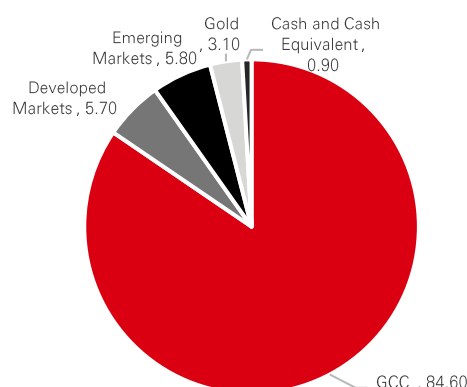

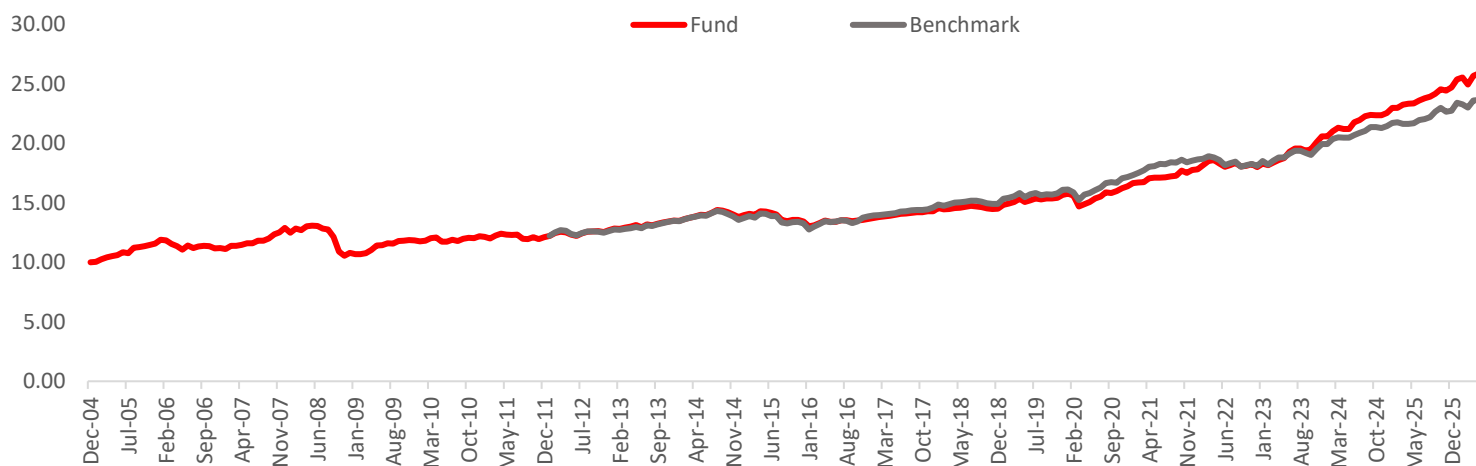


Geographical Allocation (%)⁽⁴⁾
