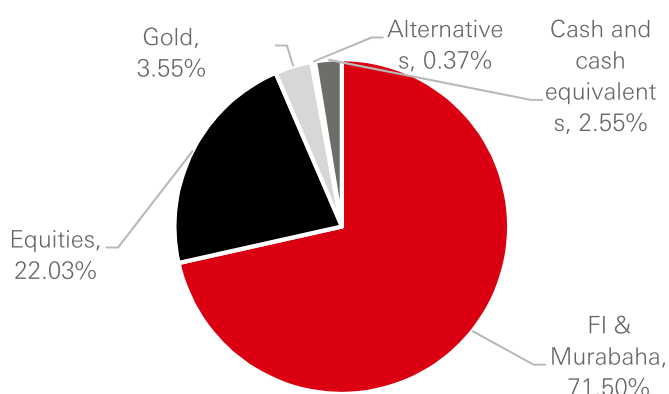

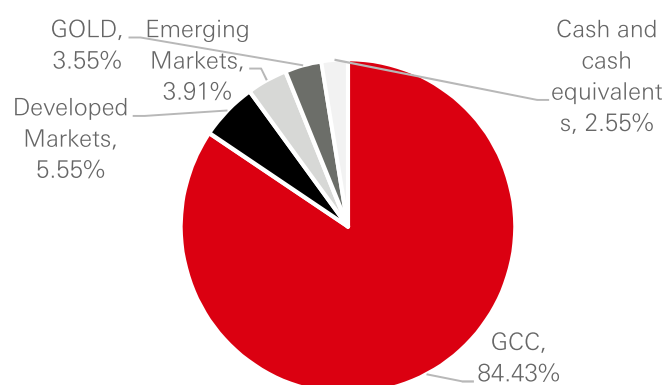

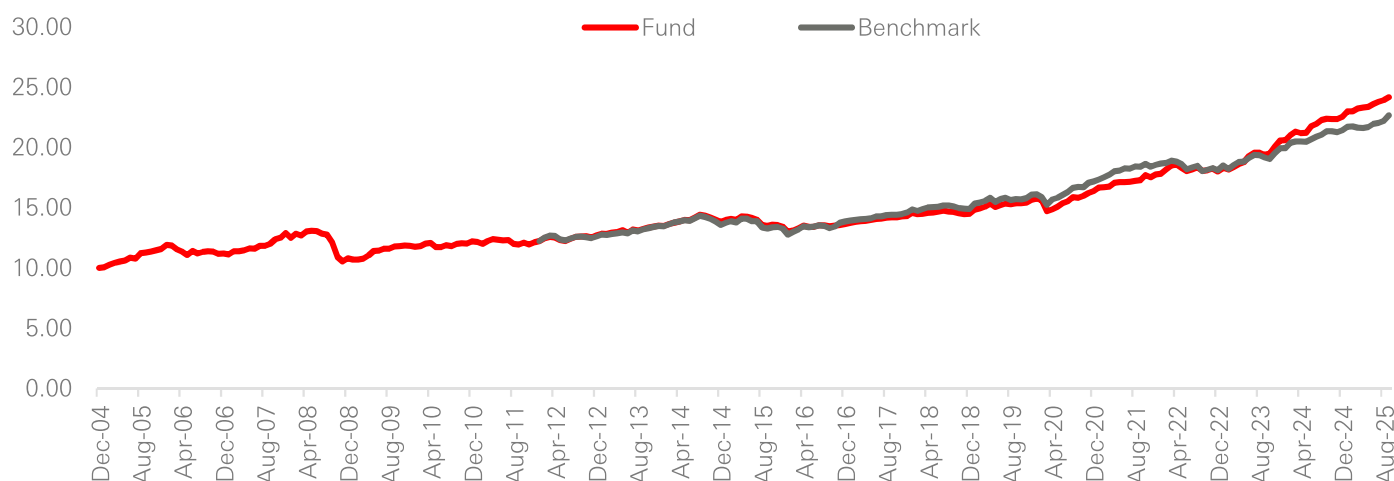


Geographical Allocation (%) ⁽⁴⁾
