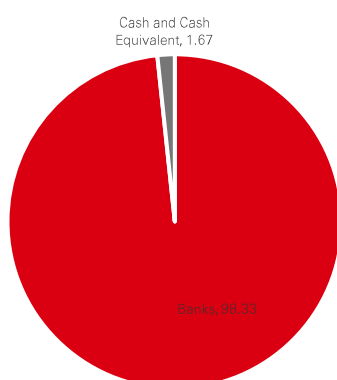

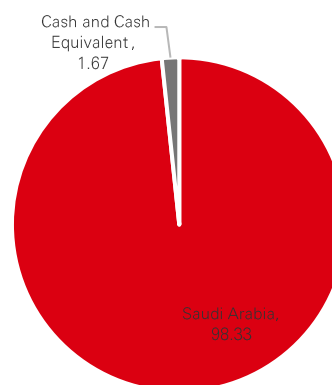

**Sector Allocation (%)**<sup>(4)</sup>

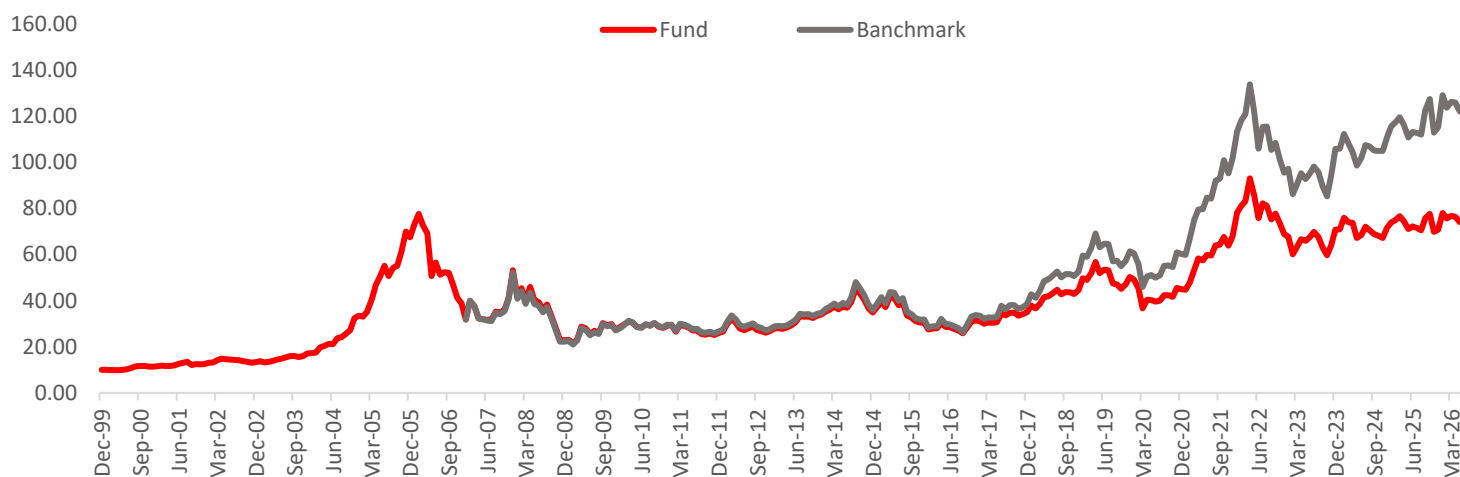


**Geographical Allocation (%)**<sup>(4)</sup>
