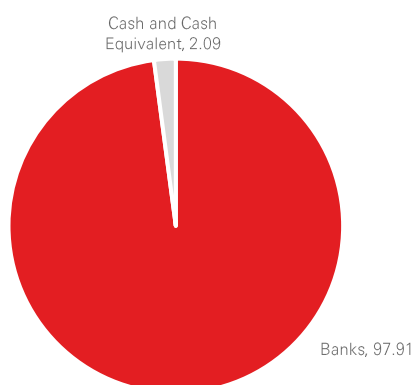

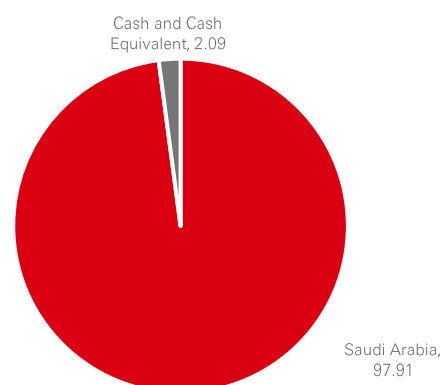

Sector Allocation (%)<sup>(4)</sup>

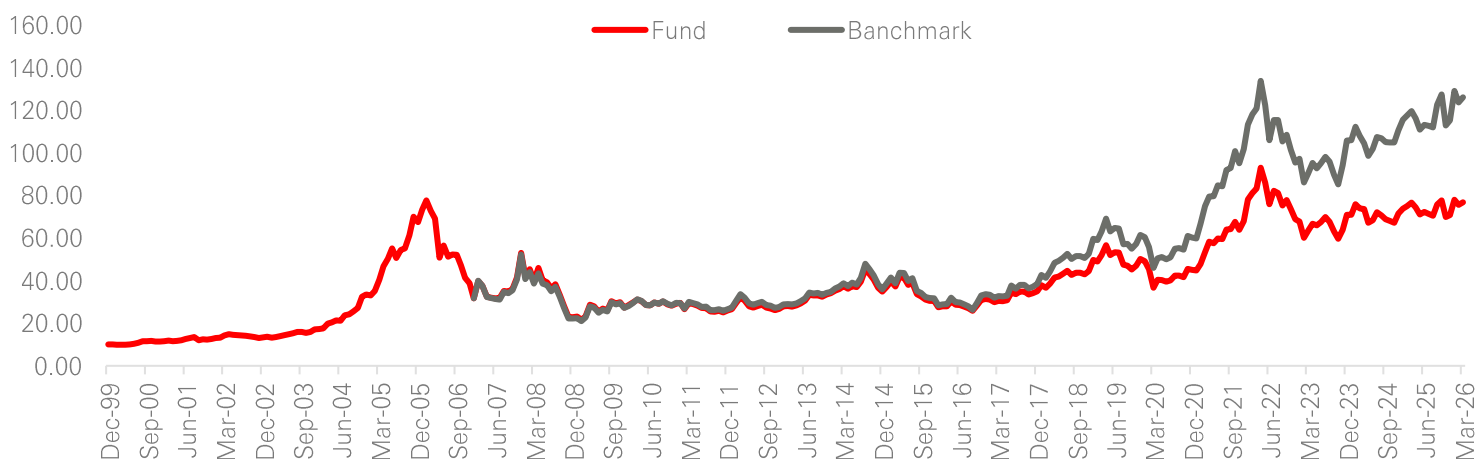


Geographical Allocation (%)<sup>(4)</sup>
