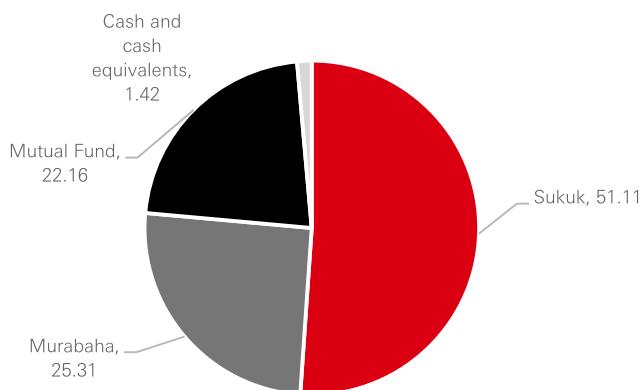

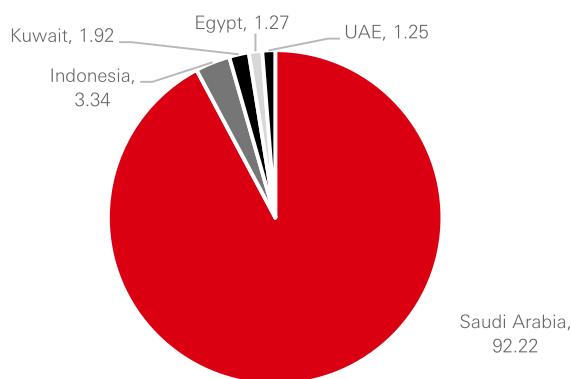

**Sector Allocation (%)<sup>(4)</sup>**

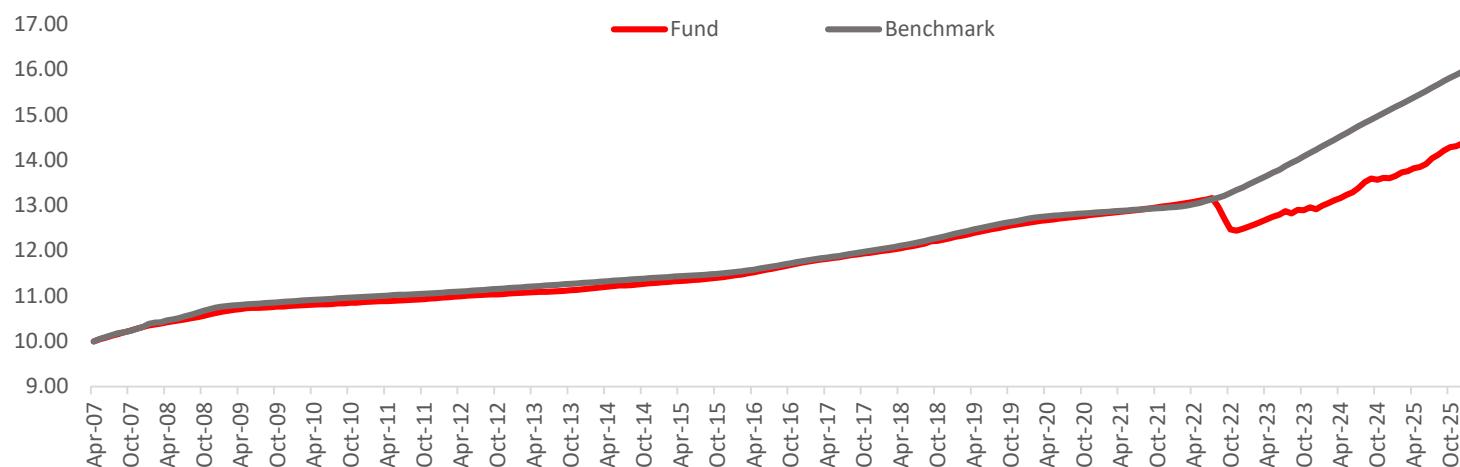


**Geographical Allocation (%)<sup>(4)</sup>**
